DISTRICT 1

GAGE COUNTY

401 Divorce, No Children

Applicant living in long-term healthcare facility is seeking assistance with an uncontested divorce. No children, no property, and no debt. Applicant has current POA.

NEMAHA COUNTY

288 Divorce, no children

Applicant seeks assistance with a divorce. The parties do not have any children. They do not own a home; they have no joint debt; and there is no dispute over personal property. Adverse currently resides in Texas.

289 Adult Guardianship

Applicant seeks assistance obtaining guardianship of disabled adult son.

DISTRICT 2

SARPY COUNTY

407 Debt Issue

Applicant seeks assistance with a medical debt.

DISTRICT 3

LANCASTER COUNTY

325 Guardianship

Applicant seeks guardianship over minor niece and nephew, whom she reports have resided with her for 9 years. Child support orders for both children have been modified to list applicant as payee. Applicant has history of serving as a foster placement for un-related juveniles.

328 Divorce, no Children

Applicant seeks assistance with a divorce. Parties have no children, but they do own property and have debt. Adverse is presently incarcerated. There is a history of domestic violence but no episodes in past 3-4 years.

342 Divorce, no Children

Applicant, who has a protection order against adverse party, seeks attorney for a divorce. The parties have no minor children, but there is real property and significant debt.

358 Divorce, no children

Senior applicant seeks an attorney for a divorce. Adverse party is currently incarcerated in Kansas. History of domestic violence. Parties have no minor children, but there is some debt.

DISTRICT 4

DOUGLAS COUNTY

323 Will & TODD

Senior applicant seeks attorney to draft a simple will and Transfer on Death Deed to transfer real property.

324 Divorce, no Children

Applicant seeks attorney for a divorce. No children or real property. History of domestic violence, but adverse party departed more than a decade ago, and whereabouts are unknown.

329 Adult Name Change

Adult applicant seeks assistance with a name change.

333 Divorce

Applicant seeks attorney for a divorce not involving children or real property. Division of debt may be an issue, but Applicant and adverse party filed Chapter 7 bankruptcy approximately 20 years ago. There is a history of domestic violence approximately 7 years ago.

338 Divorce, no Children

Applicant seeking an attorney for a divorce without children. Adverse party alleges there is domestic violence. Division of debt and real property may be an issue.

346 Divorce with children

Applicant seeks an attorney for a divorce. Neither child custody nor child support expected to be disputed. Applicant legally separated from adverse party in 2016, default Decree of Legal Separation awarded physical and legal custody of children to Applicant. No history of domestic violence.

360 Collections / Payment Plan Negotiation

Applicant seeks assistance is setting up a payment plan with judgement creditor after a default judgement was entered 4/4/2022 and Garnishment Summons issued to Applicant on 9/14/2022.

362 Divorce, no children, no real property

Applicant seeks attorney for a divorce. Parties married for 11 years, no common children, no real property, moderate debts. Applicant has resided in Nebraska for more than a year. Adverse resides in state of Georgia. There is a history of domestic violence with most recent incident approximately 3 years ago.

363 Debt collection

Applicant seeks assistance negotiating payment of credit card debt. No collection action pending at this time, but Applicant believes creditor will sue her for balance on credit card.

364 Divorce, no children

Applicant seeks an attorney for a divorce. There are no children of the marriage, but there are likely to be issues regarding real property and adverse party's retirement assets.

373 Divorce, no children

Applicant seeks attorney for a divorce with no children. Adverse has contributed to a retirement account during the marriage. Approximately \$7,000 in marital debt.

396 Divorce

Applicant seeks assistance with a divorce. Parties do not share children, property, or debt.

398 Will & TODD

Senior applicant seeks assistance with a simple will and TODD.

399 Adult Guardianship

Spanish speaking applicant seeks assistance obtaining guardianship of disabled son, who turned 19 in September.

411 Debt Negotiation

Applicant seeks assistance negotiating medical debt.

418 Will & TODD

Senior applicant seeks assistance revising current will and possible TODD.

427 Property Lien Issue

Applicant seeks assistance with property lien issue

DISTRICT 5

HAMILTON COUNTY

353 Contested Divorce, no Children

Applicant seeks an attorney for a contested divorce. No minor children of the marriage, but Applicant and Adverse own real property. No history of domestic violence.

SAUNDERS COUNTY

383 Divorce, no Children

Applicant seeks assistance for a divorce with no children and no debt. There may be some dispute over personal property.

386 Debt Negotiation

Applicant seeks assistance negotiating with collection agency about several debts. Applicant speaks Spanish.

380 Divorce, no Children

Senior applicant is resident in long-term care facility and seeks an attorney for a divorce. No children, no debt, and no property. Spouse residing in Scribner, NE.

CUMING COUNTY

339 Will and TODD

Senior applicant seeks a will and transfer on death deed.

397 Divorce

ADAMS COUNTY

372 Debt Negotiation

Applicant with an estimated \$200,000 in debt, including credit cards, personal loan, vehicle loan, and home mortgage, seeks assistance in negotiating with creditors. Applicant prefers to not file bankruptcy to discharge debts.

DISTRICT 11

DAWSON COUNTY

376 Divorce, no Children

Applicant seeks an attorney to assist with a divorce. Three children were born during marriage, but children were removed from parents' care and subsequently adopted. Applicant separated from adverse approximately five years ago and last had contact two years ago. Applicant has resided in Nebraska for past year. Adverse is homeless in Kentucky.

KEITH COUNTY

332 Will

Senior applicant seeks attorney to prepare a will. Applicant currently has a will which she seeks to update or replace. No real property, and no children

LINCOLN COUNTY

309 Child Custody

Applicant seeks assistance with custody. Applicant has children with adverse party, who is currently incarcerated. Per Applicant, adverse party is listed on birth certificate, but there has been no court order establishing paternity or child support.

355 Divorce with children

Applicant seeks an attorney for a divorce. The parties have two minor children, and a protection order is in place, but it does not include child custody provision.

422 Divorce, no children

351 Guardianship of Adult with a disability

Senior applicant seeks attorney to establish guardianship of adult grandchild with a disability. Applicant is primary caretaker of this individual. Adverse party biological father is incarcerated out of state. Adverse party biological mother does not object.

KIMBALL COUNTY

354 Divorce – no minor children

Senior applicant seeks an attorney for a divorce after 39 years of marriage. There are no minor children, but couple do have an adult child with a disability. Parties do own real estate and have significant debt. Parties filed Chapter 7 bankruptcy in 1987. There is a history of domestic violence.

Applicant with a disability seeks an attorney for a divorce. The parties have no children, no real property, no retirement assets.

341 Adult Guardianship

Applicant and spouse seek guardianship over adult child, age 28, with a disability.

Applicant seeks counsel for divorce. Parties do not share children. Parties do not share real property. Applicant is uncertain of adverse's whereabouts, and adverse is likely abroad.
