**Reduced Fee Case List**

The EVOLVES program aims to serve victims of domestic abuse and sexual violence on a reduced fee basis. Attorney fees are paid at \$80/hour by VLP. Victims do not pay any legal fees.

To indicate your interest in a case, select “Ctrl” on your keyboard and double click the case number to send an email directly to VLP. Alternatively, you can email the case number to VLP at [volunteerlawyersproject@nevlp.org](mailto:volunteerlawyersproject@nevlp.org) (please be sure to include the case number).

Once you have indicated your interest, VLP will email you the party names for a conflict check prior to placing a case with you. Upon confirmation there is no conflict in representation, VLP will then email the referral documents to you.

In some cases it may be appropriate to request an award of attorney’s fees. Attorneys are encouraged to request an award of fees when appropriate. Attorneys may retain any award of attorney’s fees or may donate all or part of the fee award to VLP.
